4 Global Challenges Research Fund

Paper B

Helen Sang had been invited by RCUK to be a member of its cross disciplinary GCRF Strategic Advisory Group. Member of the GCRF Strategic Advisory Group are expected to 'use their own networks to gather intelligence that can be brought to bear in policy developments and to disseminate RCUK policies and strategies'. Helen outlined how the RCUK GCRF strategy was evolving and encouraged members to seek her advice and provide her with information for use in RCUK discussions. It was essential that the SAG was fully engaged with the communities it represented so it could swiftly provide evidence based guidance. Members considered possible mechanisms for internal distribution of the SFC's recent allocation of funding from to support activity to be delivered with GCRF awards.

Agreed: The University's GCRF group, that RPG had agreed should be established, would be the best vehicle for disbursement of the SFC funding so that it was in line with GCRF guidelines.

Agreed: University GCRF group's membership should include the College Deans of Research, RSO, representation from the Global Academies. Other staff from thematic areas would be invited as relevant. The Group would report to RPG and would be supported by RSO.

5 REF2021 Consultation

In essence the consultation showed that the four Funding bodies accepted the Stern Review of REF2014 and recommendations therein.

Many of the proposals in the consultation had merit but some should be challenged because they could create new problems in the wake of a drive to lessen 'game-playing'. Members had a general discussion about the consultation centred on the issues of output portability and the partial decoupling of the link between the number of staff to be submitted and the number of outputs.

7 Research Information Management & Support

It was in the University's interests for the pilot to be a success.
